# **ORDER**

As per G.O read as 1<sup>st</sup> paper above, Government have designated Suchitwa Mission as the Nodal Agency for the implementation of World Bank assisted Kerala Urban Service Delivery Project (KUSDP) which is envisaged to strengthen the waste management activities of all Urban Local Bodies. As per G.O read as 2<sup>nd</sup> paper above, Government have changed the name of World Bank assisted Kerala Urban Service Delivery Project (KUSDP) as Kerala Solid Waste Management Project (KSWMP)

- 2. The Project Director, KSWMP as per the Note read as 3<sup>rd</sup> paper above has requested to sanction an amount of Rs 1,13,64,000/- through additional authorization / Supplementary Demand for Grant, so as to complete the preparatory activities to be completed prior to loan negotiations for availing the financial assistance from the World Bank.

As per G.O read as 4<sup>th</sup> paper above an additional expenditure to the tune of Rs.1,13,64,000/- was authorized under the H/A 2217-05-800-66 for meeting the administrative expenses on project preparation activities by the Kerala Solid Waste Management Project (KSWMP) to avail the World Bank share for implementing the Project.
