### **ORDER**

As per the Sanction Order read as 1<sup>st</sup> paper above, Ministry of Housing and Urban Affairs, GoI had sanctioned Central Share of Rs.96 Lakh as 2<sup>nd</sup> installment of Central Grant/VGF towards the implementation of Capacity Building Projects under SBM(U). Accordingly as per G.O read as 2<sup>nd</sup> paper above, sanction has been accorded to release a total amount of Rs.160 Lakhs (Central Share 96 Lakh & corresponding Sate Share 64 Lakh in the ratio of 60:40 ) to Suchitwa Mission by debiting the expenditure under the H/A 2217-05-191-71 for the implementation of Capacity Building Projects under SBM(U) for the year 2019-2020 .

- 2. As per the letter read as 2<sup>nd</sup> paper above the Executive Director Suchitwa Mission has reported that, except for a Q bill for an amount of Rs. 1.17 Lakh, the expenditure is not incurred and hence the balance amount of Rs. 158.83 lakh lapsed as on 31.03.2020. The Executive Director has therefore requested to take necessary action to re allot an amount of Rs.160 Lakh towards the implementation of Capacity Building Projects under SBM(U) from the current year's Budget provision.
- 3. Government have examined the matter in detail and are pleased to accord sanction to re-allot the un utilised amount of **Rs** 158.83 lakh
