ORDER

As per letter read as 1st paper above Government of India have sanctioned 2nd Instalment of Central Share for the financial year 2019-20, amounting to ₹29,38,00,000/- (Rupees Twenty Nine Crore Thirty Eight Lakh only) for implementation of the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) in Kerala. Corresponding State Share (40%) of the Central release comes to ₹19,58,70,000/- (Rupees Nineteen Crore Fifty Eight Lakh Seventy Thousand only). As per the letter read as 2nd paper above, the Commissioner for Rural Development Department has submitted proposal for the release of the aforesaid Central Share and the corresponding State Share.

2.Government have examined the matter in detail. The current year's Budget provision is not sufficient to release the entire amount. Hence, Government are pleased to accord sanction to release the 2nd Instalment of Central Share for the financial year 2019-20 along with its matching State Share, excluding the TSP component, for implementation of the projects under WDC-PMKSY in Kerala, as detailed below;
