### ORDER

As per the proceedings read above , construction of a cattle pound in Re.sy No. 125/2, Thrikkulam Desom, Tirurangadi village has been regularized by the Municipal Secretary under rule 143 of Kerala Municipality Building Rules 1999 . But the Tirurangadi Municipal Council passed a resolution to cancel the above building number - vide resolution read as 2nd above. The Municipality Secretary , in his letter read as 3rd paper above, has referred the matter to Government informing that the resolution is not legally passed and is requested to call for the records relating to the resolution and stay the implementation of the same

Government have examined the matter in detail. As per KMBR 99 in the case of all livestock and poultry farms with more than 20 numbers of birds and dairy farms more than 6 numbers of cattle, and with more than 6 numbers of dogs are under Group G2 small industrial occupancy buildings. So the proposed buildings comes under this group as per rule 30 of KMBR-99 and as per rule 57(2) if the plot area upto 0.5 hect and building area upto 500 sq.m shall be permitted by the Secretary of the local body. Also the Secretary has informed that the resolution is not legally passed.

In the above circumstances, Government are pleased to refer the matter to the Tribunal for Local Self Government Institutions for advice, as per Section 57(2) of Kerala Municipality Act 1994.
