ORDER

Government have established the Kerala Real Estate Appellate Tribunal and appointed Mr. Justice (Rtd) P. Ubaid as Chairperson of the Tribunal as per the Notifications read as 2nd and 3rd papers above respectively.

2) As per the order read 4th paper above, it was ordered that the Regional Joint Director of Urban Affairs Department, Ernakulam shall make necessary arrangements for taking the building in possession of GCDA at Marine Drive, Ernakulam on rent for housing the Tribunal or any other suitable building with necessary facilities and amenities to accommodate the Tribunal at Ernakulam, in consultation with the Chairperson. Accordingly, the Hon'ble Chairperson of the Tribunal as per letter read as 5th paper above has informed that he has identified a building for the Tribunal with the help of Regional Joint Director at Ernakulam. The building identified by the Chairperson is the first floor of a larger building consisting of two portions

with building numbers 41/3098 B and 41/3098 B1 of the Cochin Corporation, on the St.Vincent Road at Kacheripadi, Ernakulam and requested sanction to take on rent the above buildings.

3) Government have examined the matter in detail and are pleased to accord sanction to the Chairperson, Kerala Real Estate Appellate Tribunal to take the building numbers 41/3098 B and 41/3098 B1 of the Cochin Corporation, on the St. Vincent road at Kacheripadi, Ernakulam on rent as per the rates prescribed by Public Works Department, for functioning the Kerala Real Estate Appellate Tribunal. The expenditure in this regard shall be met from the Real Estate Regulatory Fund, Kerala constituted as per the order read as 1st paper above.
