ORDER

The 24th SHPSC dated 20/05/2020 approved the formation of a Technical Resource Bank (TRB) by appointment of a panel of experts with expertise in the field of Sewage / Septage Projects for assisting ULB Engineers as and when required.

As per the letter read above, the Mission Director, AMRUT has stated that the services of TRB experts can be utilized in the sector through other government agencies such as KIIFBI, Impact Kerala and Suchitwa Mission, as well as projects funded by Municipalities and also to provide technical assistance, site identification, technical clearance, technical assistance for completion of tender procedures, work award, project completion, future project preparation and implementation.

Government have examined the matter in detail and pleased to form a **Technical Resource Bank** (TRB) by appointment of panel of experts with a condition that all expenses incurred for the formation of TRB and availing expert services for implementation of AMRUT project will be borne from its A&OE fund.
