ORDER

As per per the order read as 1st paper above Administrative Sanction was accorded for the work "Providing new network in the missing areas of core city" (46 sub works)" (SAAP 2017-18) for Rs.9.95 Crores being implemented by Thiruvananthapuram Corporation.

As per the letter read as 3rd paper above the Mission Director, AMRUT has informed that the 25th SHPSC held on 15/09/2020, as per their decision No. 4.1, approved the tender excess of 40% above tendered PAC for the following 3 works:

1. TSS - Providing sewerage facility to Eastern side of Amayizhanjanthodu between Vanchiyoor junction & Samad Hospital road junction.
2. TSS - Rehabilitation of sewer line including cleaning, replacing damaged lines etc; at Kozhiyottu, Vilayil lane, Kaithamukku, Thengappura area.
3. TSS - Rehabilitation of damaged sewer network in Amma Residents

area, Palkulangara.

- Technical Sanction (TS) Amount - Rs.0.65Cr. (for 3 sub works)
- Tendered Probable Amount of Contract (Tendered PAC) – Rs.0.509Cr. (for 3 sub works)
- Lowest Quote Received – Rs.0.713Cr. (for 3 sub works)
- Tender Excess - Rs.0.204Cr. (40% above Tendered PAC, for 3 sub works)
