## **ORDER**

As per the Government order read as 1st paper above, Administrative sanction was accorded for the ULB work of Veliyilkulangara Park (SAAP 2016-17) of Kollam Corporation comes under Parks & Green Spaces Sector.

- 2. As per the decision no 5.1 in the 25th SHPSC meeting dated 22/08/2020 the proposal for revision of AS for the work, Veliyilkulangara Park (SAAP 2016-17) was approved by the SHPSC, subject to approval of the Municipal Council.
- 3. As per the letter read as 3rd paper above, the Mission Director, AMRUT has informed that the Council of Kollam Corporation have ratified the proposal vide Resolution No.67, dated 11/09/2020 and requested for the revision of the estimate due to non-provision of drainage facility in the

original estimate.

- 4. The revised estimate costs Rs.30.13 Lakh and the additional fund requirement of Rs. 1.93 Lakh shall be met from the savings in the work "Asramom Park" of SAAP 2016-17 being implemented under Parks & Green Spaces sector by Kollam Corporation, sanctioned as per the order read as 1st paper above.
- 5. Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the AMRUT Project Veliyilkulangara Park (SAAP 2016-17) comes under Parks & Green Spaces Sector for an estimate cost of Rs. 30.13 Lakh on the condition that the additional fund requirement of Rs. 1.93 Lakh shall be met from the savings in the work "Asramom Park" of SAAP 2016-17 under Parks & Green Spaces Sector being implemented by Kollam Corporation.
