As per the letter read as 4th paper above the Mission Director has informed that the 25th SHPSC as per their decision No. 4.4 approved the tender excess of 40% above Tendered PAC for the Sewerage sector work, "Laying 700 mm dia RCC NP3 Pipe Sewer Trunk Main-II from Murinjapalam - Kannamoola" (SAAP 2015-16) being implemented by Thiruvananthapuram Corporation.
