**ORDER**

As per letter read above, the Deputy Director General, Ministry of Electronics & Information Technology informed that Unique Identification Authority of India (UIDAI) has developed Child Enrolment Lite Client (CELC) application to enroll children below 5 years for Aadhaar, which has been already integrated with the Civil Registration System (CRS) of Registrar General of India (RGI). Since Kerala is using e-Sevana application for Birth and Death registrations, UIDAI has to modify the CELC application to integrate with e-Sevana for implementing Aadhaar Linked Birth Registration (ALBR) in Kerala.

2) UIDAI has already developed an API for such integration. By adopting ALBR, the Aadhaar saturation in the 0-5 age group can be improved and unique ID and related benefits can be provided. The 1600 CELC enabled tablets with Kerala State IT Mission can be utilised for ALBR. Besides, the Ministry is working with Women and Child Development department to cover enrollment of children in Anganwadis. Hence to facilitate this exercise, the Director General has requested to nominate a Nodal Officer from the Department to co-ordinate with UIDAI Tech Center for integrating e-Sevana application with CELC and to finalize roll out of ALBR in Kerala.


