ORDER

The Ministry of Rural Development (MoRD) sanctioned Karukadom - Ambalampady- Pidavoor road under PMGSY Package No KR-02-33 in Kothamangalam Block, Ernakulam District in the year 2016. Being a bridge of 55m span, KSRRDA could not submit DPR for the same along with the road proposal. The Chief Engineer, KSRRDA has reported, as per letter read above, that this bridge of is very much essential at the site. Many representations from public are also reportedly received requesting to take up the construction of this left out bridge. But the proposal for the bridge was returned by MoRD citing the condition that proposal for any road work should invariably cover all CD works. The road work is now completed. In this circumstances, the CE, KSRRDA has approached Government informing that an amount of ₹3.75 crore will be required approximately for taking up this work, which can be met from the savings of sanctioned amount of works in PMGSY-I &II or works that will be proposed to be dropped out.

2. Government have examined the matter in detail and are pleased to accord sanction to the construction of the Nadukkudy bridge in Karukadom - Ambalampady- Pidavoor road under PMGSY subject to the following conditions:

1. Administrative approval will be limited subject to the availability of savings under PMGSY I & II

2. Funds shall not be utilized from the State scheme "State Support for PMGSY" (H/A:4515-00-800-98(03)), as it is provided only for tender excess, shifting of utilities and maintenance of PMGSY roads which had completed defect liability period

3. Prior sanction shall be obtained for the construction of the bridge from the NRRDA, Government of India
