#### ORDER

As per the letter read as 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> paper above, Central Government released a total amount of ₹21.60 crore as 2<sup>nd</sup> installment of Central share for Rurban Clusters of Phase II under National Rurban Mission. Since the funding pattern of the Scheme is 60:40, the corresponding State share will be ₹14.40 crore.

- 2) The Commissioner for Rural Development as per the letter read as 4<sup>th</sup> paper above, has requested Government to accord sanction for releasing the aforesaid Central share along with corresponding State share and to transfer credit the amount to the Plan Scheme Treasury Savings Bank Accounts (PSTSB) maintained by Commissioner at District Treasury, Thiruvananthapuram.
- 3) Government have examined the matter in detail and are pleased to accord sanction for releasing a total amount of ₹36 Crore as II<sup>nd</sup> installment of Central share and its matching State share under National Rurban Mission (NRum) Phase II, as detailed below;
