### **ORDER**

As per the letter read as 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> papers above, Government of India have sanctioned a total amount ₹19,52,79,000/- as balance payment of the 1<sup>st</sup> Installment of the Central Share for implementation of the NRLM for the year 2020-21, of which General component is ₹6,54,59,000/-, SCP component is ₹7,68,42,000/- and TSP component is ₹5,29,78,000/-. As per the letter read as 5<sup>th</sup> above, the Executive Director, Kudumbashree has requested to release the aforesaid Central Share along with the corresponding State Share for the above purpose.

- 2. Government have examined the matter in detail. Since sufficient fund is not available in the State Share of TSP component under the H/A '2501-06-796-99', the release of TSP component will be considered after getting the Additional Authorization.
- 3. In the above circumstances, Government are pleased to accord sanction to the release of total amount of ₹23,71,68,333/- (Twenty Three Crore Seventy One Lakh Sixty Eight Thousand Three Hundred and Thirty Three only) being
