ORDER

As per the letter read as 2nd paper above, Government of India sanctioned the grant-in aid amount of Rs.1,40,00,000/- (Rupees One Crore forty Lakh only) as Central Assistance for the Syama Prasad Mukherji Rurban Mission (SPMRM) Clusters (35 Lakhs for each cluster) under Phase III, namely Nedumpana & Thrikovilvattam, Puthukode & Kavassery, Thanalur & Niramaruthur, Kadalundy & Olavanna for the preparation of Integrated Cluster Action Plan (ICAP) and for setting up institutional arrangements.

2) As Government of India has not approved the Kadalundy & Olavanna cluster under phase III, sanction was accorded only for the release of an amount of Rs.1,05,00,000/- (Rupees One Crore Five Lakh Only) towards the Administrative expenses for the other three Clusters vide Government Order read as 3rd paper above. As per the letter read as 4th paper above, Government of India has approved the conversion of Pinarayi-Vengad in Kannur District as

4th Cluster in Phase III in place of Olavanna-Kadalundy Cluster and also directed to utilize the administrative fund of Rs.35 Lakhs already released vide letter read as 2nd paper above, for preparation of ICAP for Pinarayi-Vengad Cluster. As per the letter read as 5th paper above, the Commissioner for Rural Development has submit the proposal for the authorization of additional expenditure for an amount of Rs.35 lakh under the Head of account 2515-00-102-35-SPMRM (P) from the current years budget allocation, and authorizing the Commissioner for Rural Development to draw the amount and transfer credit to the PSTSB account of 799012700000267 at District Treasury, Thiruvananthapuram.

- 3) Government have examined the matter in detail, and are pleased to accord sanction for the release of an amount of Rs.35,00,000/- (Rupees Thirty Five Lakh Only) towards the Administrative expenses for Pinarayi-Vengad Cluster under SPMRM Phase III for preparing ICAP and for setting up institutional arrangements under the Head of Account 2515-00-102-35-SPMRM (Plan) from current year's budget provision.
- 4) The amount will be transfer credited to the PSTSB Account No.799012700000267 maintained at District Treasury, Thiruvananthapuram and the Commissioner for Rural Development is authorized to draw and disburse the amount for the above purpose.
