ORDER

As per the Sanction Orders read as 2nd paper above, Government of India have sanctioned the grant-in-aid amount of ₹24,14,00,000/- (General), ₹14,00,12,000/- (SCP), ₹10,13,88,000/-(TSP) respectively towards the 2nd installment of Central Share for implementation of placement linked Skill Development Project for 71200 candidates under DDU-GKY approved in Action Plan 2016-19 by Kudumbashree, Kerala SRLM. As per the Government Order read as 4th paper above, sanction has been accorded to release the 50% of aforesaid Central Share along with its corresponding State Share to Kudumbasree.

2) As per the letter read as 5th paper above, the Executive Director, Kudumbasree has reported that State Share of SCP and TSP Component amounting to ₹8,04,75,000/- sanctioned as per G.O. read as 4th paper above was not credited to the Account of Kudumbasree during the Financial year 2018-19.
