ORDER

The XV Finance Commission has recommended an amount of ₹445 crore consisting of two equal parts – 50% basic grants and 50% Tied grants for Urban Local Governments other than Million Plus cities as FFC Grant for the year 2020-21.

- 2) The 1st instalment of Untied Basic Grant released from the Ministry of Finance has been authorized to Non Million Plus cities. But Many of the LGs have requested to authorize FFC Grant as they have bills in the treasury to be cleared. The second instalment of Basic Grant as well as 1st and 2nd instalment of Tied Grant has to be authorized to ULGs other than Million plus cities even though the same have not been received from Govt of India.
- 3) Government after having examined the matter in detail, are pleased to issue the following orders:
 - a) An amount of ₹333,38,67,225/- (Rupees Three hundred and Thirty Three crore Thirty Eight lakh Sixty Seven thousand Two hundred and Twenty Five only) is authorized to 86 Non-Million Plus cities as 2nd instalment of Untied Basic Grant and 1st & 2nd instalment of Tied Grant under 15th Finance Commission Award as detailed below:

- b) Basic Grant shall be used by the LGs for location-specific felt needs, except for salary and other establishment expenditure.
- c) Tied Grant shall be used by the LGs for the basic services of (a) sanitation and maintenance of open defecation free status (ODF) and (b) supply of drinking water, rain water harvesting and water recycling. The local Governments, as far as possible, shall earmark one half of the Tied Grant to each of these two critical services. However, if any LG has fully saturated the needs of one category, it can use the funds for the next category.
- d) LGs shall utilize the Grant as per the Guidelines issued vide Government read as 4th paper above.
- e) This order shall be considered as an allotment letter.
- f) Director of Treasuries shall make available copies of this order to the Dist /Sub treasuries through Treasury intranet.
