ORDER

As per the recommendation of XV Finance Commission, an amount of Rs.339 crore has been allocated to Million Plus cities (Urban Agglomerations) as Tied Grant for the FY 2020-21 (6 Municipal Corporations and Malappuram Municipality).

- 2) An amount of Rs.195,69,77,500/- ,vide Government orders read as 4th and 5th papers above was already authorized under Basic Grant to Million Plus cities for clearing the bills in the treasury queue as there was no award under Basic Grant recommended by XV Finance Commission to these ULGs.
- 3) Considering the requests of ULGs to authorize the Tied Grant, Government are pleased to issue the following orders:
 - a) An amount of Rs.339,00,00,000/- (Rupees Three hundred and Thirty Nine crore only) is authorized as XV FC Tied Grant to 7 Urban Agglomerations (6 Municipal Corporations and Malappuram Municipality) even though the same has not been received from the Govt of India, as detailed below:
