ORDER

The Hon'ble Kerala Administrative Tribunal, as per its order read as 1st paper above, has disposed of OA(EKM) 858/2020 directing the 2nd respondent, the Chief Engineer, LSGD, to pass appropriate orders on Annexure A6 representation, read as 2nd paper above, as expeditiously as possible, at any rate, within a period of six weeks from the date of receipt of a certified copy of the order.

- 2. In the Annexure A6, the applicant has contended that his rank no. in the combined seniority list of Asst.Engineer published by the Chief Engineer on 18.05.2020 is 83 and his junior Sri. David John D'Morris who is ranked no.91 was promoted to the cadre of Exe.Engineer on 23.01.2018. The applicant has requested to reassign his date of promotion as Exe.Engineer w.e.f promotion of his junior, ie 23.01.2018 and to include him in the seniority list of Exe.Engineers for the period from 31.12.2016 to 31.08.2018.
- 3. The Chief Engineer, LSGD, vide letter read as 3rd paper above, has reported that, in compliance with the order of Hon'ble Supreme Court dated 05.02.2020 in Civil Appeal(S)no.6165/2017, the combined Seniority list of Assistant Engineers has been published vide E22/4358/2020/CE/LSGD dated 18.05.2020. Then the process of rearranging the seniority list of Assistant Executive Engineers has been initiated by convening the review DPC(H) on 25.09.2020 for re-arranging the select list for the promotions of the Assistant Executive Engineer from 2010 to 2019. In order to publish the final seniority list of Assistant Executive Engineer, the revised draft seniority list of Assistant Executive Engineer for the published soon as and when the select list of Assistant Executive Engineer for the period from 2010 to 2019 is prepared by the lst respondent, i.e., Govt. After finalizing the seniority list of Assistant Executive Engineers, another review DPC will be convened to regularize the promotion of Executive Engineer in accordance with the seniority list of Assistant Executive Engineers. At that time the request of the applicant will be considered. The

authority competent to revise the seniority list of Executive Engineer is the Government.

- 4. Government have examined the matter in detail, being the authority competent to revise the seniority in the cadre of Executive Engineer. The request of the applicant for reassigning his seniority in Exe.Engineer w.e.f date of promotion of his junior can only be considered at the time of reviewing the select list for promotion to the post of Exe.Engineer by the review DPC(H) to be convened after the publication of revised seniority list of Asst.Exe.Engineer. Hence, the request in Annexure A6 representation is hereby disposed of informing that the matter will be considered in the review DPC(H) to be held after finalising the seniority list of Asst.Exe.Engineer.
- 5. The order of the Hon'ble KAT in OA(EKM) 858/2020 read as I^{st} paper above, is hereby complied with.
