ORDER

Government of India vide letter read as 1st paper above have released an amount of ₹103,93,42,000/- to the State Government of Kerala being the 2nd installment of 1st tranche of Central assistance towards Material and Administrative contingency for implementation of MGNREGA for the financial year 2020-21. The Mission Director, MGNREGS vide letter read as 2nd paper above, submitted a proposal for release of Central share received along with the corresponding State share (25% for Material Component) ₹20,30,94,000/-. As there was no component-wise bifurcation for the central release, the Mission Director submitted the proposal based on requirement.

Government have examined the matter in detail and are pleased to accord sanction to release a total amount of ₹124,24,36,000/- (Rupees One Hundred and Twenty Four Crore Twenty Four Lakh and Thirty Six Thousand Only), comprising of ₹103,93,42,000/- (Rupees One Hundred and Three Crore Ninety Three Lakh and Forty Two Thousand Only) as the 2nd installment of
