ORDER

As per Letter read as 1st paper above CEO LIFE Mission has informed that the construction of 10 Pilot towers are in progress and at different stages. Preliminary works are in progress at 14 sites. Total tendered amount for the apartment complex works is Rs. 222 Crore. In addition to this GST and PMC charge to be paid.

2. Since the building is of prefabricated structure, initial capital investment required is high and mobilisation advance clause has been provided in the contract. Time of completion of the work is 6 months except for two works. All these projects are planned to be completed in a time bound manner. Any delay in making payment to contractor may result in delay in completion of the project.

3. It is informed that for Mobilisation advance, Contractors bills received for 10 pilot towers, payment up to stage-II, GST and PMC charge are the payment to be made immediately. Hence it is requested by CEO, LIFE vide letters read (1) and (3) above to transfer credit an amount of Rs.50 Crore to the LIFE Mission's PSTSB account number 799012700001688 with District treasury, Thiruvananthapuram from the Heads of Account detailed below-
