Read Interim Order of the Hon'ble Kerala Administrative Tribunal dated 12.08.2020 in OA(E) no. 949/2020.

ORDER

The Hon'ble Kerala Administrative Tribunal, as per its interim order read above, has directed the respondents 2 & 3, i.e., the Chief Engineer and the Convenor, DPC(H) respectively, to place the applicant in the zone of consideration for promotion to the post of Asst.Exe.Engineer in the next meeting of the DPC and his eligibility and merit will be determined but for the departmental proceedings initiated against him and the findings will be recorded in a separate sheet attached to the proceedings.

2. The DPC(H) held on 25.09.2020 considered the eligibility of the applicant who was included as SI no.35 & Rank no.589 in the field of choice for promotion to the post of Asst.Exe.Engineer and observed that though the disciplinary action for major penalty pending against him in Govt file no.6859/EW1/2012/LSGD was finalised by barring two annual increments with cumulative effect, vide GO(Rt)no.3043/c2018/LSGD dtd 30.11.2018, the disciplinary proceedings is imposed during the check period and hence he is ineligible for inclusion in the select list as per Rule 28(b) (i) 14(ii) Part II KS&SSRs. Accordingly it was decided to supersede him in the select list for promotion to the post of Asst.Exe.Engineer for the year 2020. The said select list has been approved by Govt vide GO (P)no.63/2020/LSGD dated 04.11.2020.

3. As the eligibility of the applicant for promotion to the cadre of Asst.Exe.Engineer has been considered by the DPC(H), the direction of the Hon'ble KAT in its interim order in OA(E) no. 949/2020 is complied with accordingly.
