The Accountant General reported that the officer has not availed any leave other than casual leave during the period of probation. No disciplinary action was pending against the incumbent during the period of probation.

The probation period in the post of Municipal Secretary Grade III is two years duty within a continuous period of three years. Hence the period of probation in respect of Shri.Sanil S is from 22.03.2017 to 21.03.2019 .But he passed the departmental test on 24.10.2019. Hence the period of probation of the incumbent is to be extended up to 24.10.2019 FN.
