ORDER

As per the Government order read as 5th paper above the term of the contract of the staff recruited for the Programme Management Unit (PMU) of Rashtriya Gram Swaraj Abhiyan(RGSA) was extended to 30/6/2019. The PMU was functioning under the Director of Panchayath, with a structure of a Team Leader, 15 MIS Specialists and one Computer Programmer. As per the revised guidelines of RGSA, the PMU shall contain experts in the field of Planning, Training, Economic Development, Social Justice, Project Management, Media & IEC, MIS, Procurement & Disbursement etc. Considering this, it was decided to restructure the PMU by terminating the existing contract staff after the date of expiry of the extended contract period. The Director of Panchayaths have given a notice on 28/6/2019, so as the incumbents need not permitted for the duty with effect from 1/7/2019. Against this, the incumbents have approached Hon'ble High Court of Kerala. The Hon'ble High Court, in its Judgment read as 6th paper above, has ordered as follows.

"Ext.P7(a) order is set aside. Petitioners shall be allowed to continue till appointments are made in accordance with the restructuring proposed in Ext.R3(b) on its approval by SEC. Respondents would be free to evaluate the performance through officials competent for the same and their continuance would also be subject to such evaluation in accordance with law. The arrears of salary due to the petitioners, if any, shall be paid within a period of two weeks."

Exhibit P7(a) was the letter issued by the Director of Panchayaths dated 28/6/2019.

- 2. As per the direction of the Hon'ble High Court, the State Executive Committee has decided to restructure the PMU and formed a Technical Sub Committee to furnish proposals regarding the structure and selection methods. Subsequently, the Technical Sub Committee has furnished proposals to Govt.
- 3. Government have examined the proposal in detail and are pleased to restructure the PMU with 24 posts, as cited in the Annexure to this Government Order. The terms and conditions stipulated in the Govt Orders read as 1st -4th paper above shall be followed scrupulously. The post sanctioned on deputation shall be appointed as such.
- 4. The PMU will be under the control of Director of Panchayath and an Officer not below the rank of the Panchayath Joint Director shall be selected as the Team Leader.
- 5. The direction of Hon. High Court in judgement dated 23/10/19 in WP(C)No.17714/2019 filed by Sri. Anupkrishna.P and others is complied herewith.
