ORDER

As per Government Order read as 1st paper above, Government have accorded sanction for establishing 5MW solid Waste-to-Energy (WtE) plants on Design, Build, Finance, Operate and Transfer (DBFOT) basis in Public-Private-Partnership (PPP) mode at 7 sites, one each in Thiruvananthapuram, Thrissur, Palakkad, Kozhikode, Kannur, Kollam and Malappuram Districts.

- 2. As per Government Order read as 2nd paper above, Government have constituted a Bid Evaluation Committee for clarifying the doubts and queries likely to be raised by the prospective bidders at the pre-bid meeting and also for evaluation of pre qualification and technical bids in connection with selection of bidders for establishing Waste to Energy Plants in the State.
- 3. Inorder to have a detailed evaluation on a broad spectrum of technical, legal and financial aspects of the technical bids submitted as part of the international bidding process, as per the letter read as 3rd paper above Managing Director, Kerala State Industrial Development Corporation has requested to reconstitute the Bid Evaluation Committee by including representatives from Environment Department, Finance Department and State Pollution Control Board
