  ORDER

As per Government Order read as 1st above, Shri.Praveen A., former Secretary, Sreekandapuram Municipality was suspended from service, based on the report of District Collector, Kannur.

As per the judgement dated 27.10.2020 in OA 1389/2020 filed by Shri Praveen.A. the Hon'ble Kerala Administrative Tribunal directed the first respondent to pass orders on the review petition submitted by the applicant within two weeks. If no orders on the review petition are communicated within 2 weeks, the applicant shall be reinstated in service with effect from 16.11.2020 and the 2nd respondent shall issue appropriate posting order to the applicant.

In the circumstances Government have examined the matter and are pleased to reinstate Sri.A.Praveen, Municipal Secretary, Sreekandapuram Municipality (under suspension) into service and to post him at Urban Affairs Directorate. The Director of Urban Affairs will take further necessary action in this regard.

The Judgement dated 23.06.2020 in OA No. 235/2020 and Judgement dated 27.10.2020 and 18.11.2020 of Hon'ble Kerala Administrative Tribunal in OA No. 1389/2020 are complied with accordingly.
