Sub:- Recruitment of Part Time Sweepers through Kudumbasree

2) G.O (P) No. 61/10/Fin. dated: 9/2/2010.

In the Government Order 2<sup>nd</sup> cited it was interalia ordered that all fresh appointment of sweepers in temporary establishments irrespective of sweeping area and in permanent establishments where the sweeping area is less than 100M<sup>2</sup>, shall be made only through Kudumbasree with effect from the date of the Government Order.

It has come to the notice of the Government that certain Heads of Departments are taking steps to terminate the service of the existing Part Time Sweepers who have been working since years, and to appoint persons from Kudumbasree.

In this circumstance Government are pleased to clarify that the intention of Government while issuing Government Order referred to above is not to terminate the services of the existing sweepers but with regard to future appointments only. Hence all Heads of Departments are directed to fill the vacancies that arose after 9/2/2010 through Kudumbasree as specified in the Government Order second cited in Offices that are temporary and those

having sweeping area less than 100m<sup>2</sup> and not to disturb those continuing prior to the above date.
