**ORDER**

The 15<sup>th</sup> Finance Commission has recommended an amount of ₹445 crore consisting of two equal parts – 50% Basic grant and 50% Tied grant for Urban Local Bodies other than Million Plus cities/ Agglomerations for the year 2020-21.

2) As per Government Order read as 3<sup>rd</sup> paper above, FC Grant and Normal share under Development Fund have been modified on the basis of the recommendations of the XV Finance Commission.

3) In order to clear the bills in the Treasury and due to the delay in release of XV FC Grant from Govt of India, second instalment of Basic Grant and 1<sup>st</sup> & 2<sup>nd</sup> instalment of Tied Grant amounting to Rs.111,12,87,225/- and Rs.222,25,80,000/- respectively has been authorized in advance to 86 Municipalities as XV FC Grant to Non Million Plus cities vide Govt order read as 4<sup>th</sup> paper above.

4) As per letter read as 5<sup>th</sup> paper above, Government of India have conveyed the sanction of release of ₹111.25 crore as 2<sup>nd</sup> instalment of ULBs Tied Grant under 15<sup>th</sup> Finance Commission Award to Non-Million Plus cities for the year 2020-21 and requested the State to make allotment of grants on population basis to Cantonment Boards also.

5) Government, after having examined the matter in detail, are pleased to accord sanction to transfer credit a sum of Rs.12,10,000./- (Rupees Twelve lakh Ten thousand only) to Cannanore Cantonment Board as 2<sup>nd</sup> instalment of ULB Tied Grant



under 15<sup>th</sup> Finance Commission and to order that the State has complied with the release of second instalment of Tied Grant to Non Million Plus Cities (86 municipalities) considering the amount authorised vide Govt order read as 4<sup>th</sup> paper above prior to this release

6) US, Fin (Accts) is authorized to transfer credit an amount of Rs.12,10,000/- (Rupees Twelve lakh Ten thousand only) to the Bank account of Cannanore Cantonment Board by debit to the head of account '3604-00-200-85-(07)-35' as detailed below:
