ORDER

There are a lot of complaints regarding the manner in which applications under Building Regulation Rules are being considered in the various offices of the local bodies as well as in District Town Planning Offices. Therefore, a provision for surprise inspection of the processing of building regulation applications in the local bodies and the District Town Planning offices will prove to be a healthy measure in counteracting possible corrupt practices. Government are, therefore, pleased to constitute a Vigilance Cell consisting of a Deputy Secretary, a Senior Town Planner and a Confidential Assistant, in the Local Administration & Social Welfare Department, Secretariat to scrutinise the files on exemption from building regulations in Municipalities, Corporations, Town Planning Trusts, Development Authorities, District Town Planning offices and Panchayats and also to undertake local inspections wherever necessary.

2. Sanction is also accorded for creation of the following posts for the period upto 28-2-1981 for the Vigilance Cell in the Local Administration & Social Welfare Department, Secretariat.
