ORDER

The Information Kerala Mission has undertaken the Implementation of Fast Track Computerisation of 53 Municipalities in the State as priority projects under the Hundred Days Programme of Government, vide Government Order Ist read above. In the Government Order as 3rd paper above Government have issued Technical Sanction for the establishment of Janasevana Kendrams in Municipalities.

The Implementation Committee of Information Kerala Mission in its meeting held on 23/11/2004 has decided to advance funds from Information Kerala Mission's Additional Central Assistance for the purpose as requested by certain Municipalities. It was also decided that the funds so advanced by Information Kerala Mission be recouped later form the Annual Plan Assistance of the respective Local Self Government Institutions for the year 2005-2006.

In the Government Order 2nd read above, Government have accorded sanction to Information Kerala to provide funds to the Municipalities for establishing Janasevana Kendrams on condition that they shall furnish an undertaking in stamp paper worth Rs. 100/- to the effect that Municipalities will deduct the amount advanced by Information Kerala Mission from their 2005-2006 Plan Grant-In – Aid. Accordingly, the Municipalities concerned have furnished undertakings to Information Kerala Mission.

As per the Government Order 4th read above, sanction was accorded for the release of 5/12 of the funds allotted for the Local Self Government Institutions in the budget provisions for 2005-2006 as first Instalment of Plan Grant-In- Aid to the Local Self Government Institutions. It was also ordered that the Director of Urban Affairs shall allot funds to the Municipalities directly.

In the above circumstances and considering the fact that works on Janasevana Kendrams are almost nearing completion, Government are pleased to order that the funds advanced by Information Kerala Mission to the Municipalities for establishing Janasevana Kendrams shall be repaid to Information Kerala Mission from the Plan Grant-In- Aid. released vide Government Order 4th read above, before 30/05/2005.

The list of the Municipalities, the amount advanced by Information Kerala Mission, the amount to be repaid are appended.


