### ORDER

Sanction was accorded as per Government Order read as 1st paper above for implementation of the scheme "Kerala Information Network for Local Bodies" for inter connecting all the Local Bodies in the state and District Planning Offices and the State Planning Board through a computer connectivity for swift and precise monitoring implementation of the plan scheme by the Local Bodies and for automation of their various activities, utilizing the central Assistance received for the purpose. The scheme is being implemented by a Mission Group drawn from C-DIT known as Information Kerala Mission (IKM).

2. The sanctioned term of the Mission which expired on 31.3.2001 was further extended by one year from 1.4.2001 as per G.O. read as 2nd paper above. The term of the Mission was further extended by two years from 1.4.2002 as per G.O. read as 3rd paper above and one year from 1.4.2004 as per G.O. read as 4th paper above.

3. In the letter read as 5th paper above, the Executive Mission Director, Information Kerala Mission requested to extend the term of Information Kerala Mission for a further period of 2 years w.e.f. 1.4.2005.

4. Government have examined the matter in detail and are pleased to accord sanction to extend the term of Information Kerala Mission for a further period of 2 years from 1.4.2005.


