ORDER

The Information Kerala Mission was constituted as per G.O read as 1st paper above. An Implementation Committee and a Technical Committee consisting of 16 members was also constituted to oversee the project implementation. As per G.O read as 4th paper above, the implementation committee of the Mission was reconstituted with 9 members . But the Technical Committee was not reconstituted.

As per G.O. read as 7th paper above Shri. P.V.Unnikrishnan, Executive Mission Director of the Information Kerala Mission has been made as a member of the State Planning Board. As per G.O. read as 8th paper above Prof. M.K. Prasad , formerly Pro.Vice Chancellor of Calicut University , has been appointed as Director of Information Kerala Mission.

As per G.O. read as 9th paper above Shri.M.Sivasankar,IAS (KL:1995) has been put in full additional charge of Executive Mission Director, Information Kerala Mission.

Considering the requirements for the functioning of the Mission and its various activities relating to the State level rollout of IT application in the Local Governments, Government are pleased to issue the following orders.

- (i) Prof.,M.K. Prasad ,Director of Information Kerala Mission will function as Executive Chairman of the Mission . He will chair the Executive Committee.
- (ii) Shri.K.Prem Kumar, now Joint Director (Technical Support and Infrastructure Management) will function as Director (Technical).
- (iii) Shri.P.V.Unnikrishnan , Member ,State Planning Board will function as Vice Chairman of the Mission . He will also be its Chief Informatics Officer with the mandate to assist in design of the various applications of the Mission and their deployment and also advice on technology issues.

Sanction is also accorded to constitute a Governing Council in the place of the Implementation Committee and an Executive Committee in the place of the Monitoring Committee consisting of the following members for overseeing the activities of the Mission.
