ORDER

1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2.As per the Government Order read as 2nd, 3rd and 4th papers above, sanction was accorded for the release of 1st, 2nd and 3rd instalments of Traditional Functions (General Purpose Fund) for the months of April, May and June 2008 respectively
3. As per the Government Order read as 5th paper above, an amount of Rs. 30,24,94,832/- (Rupees Thirty Crore twenty four lakh ninety four thousand and eight hundred and thirty two only) for Traditional Functions (General Purpose Fund) was transfer credited from the Consolidated Fund under the major Head of Account "3604 - Compensation and Assignments" to Local Bodies and Panchayat Raj Institutions to the Public Account under the major Head "8448 - Deposits of local funds" as 4th instalment for July 2008, as detailed in the statement appended and also sanctioned its release.
3. Accordingly sanction is accorded for the release of the above amount of Rs. 30,24,94,832/- (Rupees Thirty Crore twenty four lakh ninety four thousand and eight hundred and thirty two only) to Local Self Government Institutions being the 1/12th of the total allocation, as appended to this order, based on the distribution shown in Appendix IV to the Detailed Budget Estimates 2008-09 in respect of Category -D, Funds for Traditional Functions (General Purpose Fund).

4. The distribution of funds among the Local Self Government Institutions effected are as shown in the statement appended to this Government Order. The amount so transfer credited is exempted from treasury restrictions.

5. The Director of Panchayats will release the 4th instalment, being 1/12th of the funds earmarked for Traditional Functions (General Purpose Fund), to the Grama Panchayats. The Director of Urban Affairs will release the 4th instalment being 1/12th of the funds earmarked for Traditional Functions (General Purpose Fund) to the Municipalities. The Commissioner for Rural Development will release the 4th instalment to the Block Panchayats in accordance with the guidelines prescribed in para 3 of the Government Order read as 1st paper above.

6. Government are pleased to release the following amounts as the 4th instalment of Traditional Functions (General Purpose Fund) to the District Panchayats and the Corporations as follows:


