ORDER

Government, as per the Government orders read as 1st, 2nd & 3rd papers above, issued orders varying the structure plan (General Town Planning Scheme) for central city of Kochi, the general Town Planning Scheme for Trivandrum and the Development Plan (General Town Planning Scheme) for Calicut urban area respectively.

In the above said orders, interalia, under item 4.13 (ix), General guidelines item No.(vi) and item No.5 respectively it was ordered that a committee for recommending large scale development proposals in an area not less than 2 Hector, exceeding an investment of Rs.50 crores which provide direct employment to not less than 500 people in agricultural and developed land use zone, shall be constituted by the Government for this purpose under the Chairmanship of Secretary, LSGD consisting of Chief Town Planner, Regional Town Planner of the District, Secretary of the Development authority and Secretary of the Local Body concerned.

Accordingly the Chief Town Planner as per the note read above has submitted proposals for the constitution of the Committees for Kochi, Trivandrum and Calicut.

After having examined the matter, Government are pleased to constitute the following committees for the above purpose for Kochi, Trivandrum and Calicut.
