ORDER

1. Government are pleased to appoint Prof. M.K. Prasad, former pro-vice Chancellor Calicut University [62, Giri Nagar, Ernakulam] as the Director of Information Kerala Mission, Thiruvananthapuram.
2. His responsibilities would be
 - (1) Undertake a comprehensive review of the activities of the Mission, achievements so far, shortfalls and develop a Result Based Management frame work to streamline the Mission's activities for time bound delivery.
 - (2) Undertake a review of the roles and responsibilities of the various functionaries in Information Kerala Mission and revamp the organisational structure suitably.
 - (3) Draw up a proposal for capability building of the Local Government leaders in e-Governance, Service Delivery and Business Process Reengineering which shall be integrated with various other capacity building programmes of the Local Government Department.

- (4) Demarcate the roles of Information Kerala Mission and the Local Governments in implementation of Information Kerala Mission's applications and mobilise the active involvement of Local Governments in the endeavour.
- (5) Initiate efforts to integrate the activities of the Mission with the Kerala Sustainable Urban Development Project (KSUDP), Jawaharlal Nehru National Urban Renewal Mission (JNNURM), Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT) and other centrally sponsored and externally funded projects with governance improvement components.

3. Terms of appointment are:

1. He will be paid an honorarium of the Rs. 25000/- per month
2. He is eligible for ~~5~~ travel allowance applicable to Class I Officers of Government of Kerala.
3. He will be provided hired accommodation at Thiruvananthapuram for an amount not exceeding Rs.3000/- per month.
4. He will be provided an Office car, Residential Telephone and the services of a Confidential Assistant
