In the above circumstances, Govt. have examined the matter in detail and are pleased to order the following modification to the Govt. Order read as 1st paper above.

Para 2(6) of the Govt. Order read above is modified by incorporating the following.

"The posting of Finance Officer in the District Panchayats of Kerala or their reversion from the post should be done in consultation with the concerned Administrative Department".

The following condition is also incorporated in the Govt. order read as 1st paper above.

"Deputy Secretaries are also considered along with Under Secretaries for the post of Finance Officer as an Under Secretary in the Administrative Secretariat/Finance Department will get promotion or cadre promotion within a period of 3 years".

The Govt. Order read as 1st paper above stands modified to the above extent.
