## ORDER

- In the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per the Government Order read as 2nd paper above, deductions corresponding to the shortfall in expenditure exceeding 20% of the allocation in 2006-07 were made in the budget allocations to the respective Local Self Government Institutions for the financial year 2008-09.
- 3. As per the Government Orders read as 3rd, 4th, 6th, 7th, 8th, 9th, 10th and 11th papers above, sanction was accorded for the release of 1st, 2nd, 3rd, 4th, 5th, 6th, 7th and 8th instalments of Development Fund for the months of May, June, July, August, September, October, November and December 2008.

- 4. In the Government Order read as 12th paper above, sanction was accorded for the release of 1/10<sup>th</sup> of the allocation earmarked to the Local Self Government Institutions in respect of funds for Expansion and Development under different sectors as per the distribution in Appendix IV to the Detailed Budget Estimates 2008-09 from the funds transfer credited to the public accounts under the major head of account "8448-Deposits of local funds".
- 5. In the Government order read as 5th paper above, it has been stipulated that plan fund will not be released until the Local Self Government Institutions submit the accounts of expenditure through the District Planning Committees concerned to the controlling officers. In the case of District Panchayat and Corporations withheld letters of authority for the release of 3rd, 4th, 5th, 6th, 7th and 8th instalments of funds for Expansion and Development have been issued considering deficiency of fund for developmental activities pending receipt of the report from district planning officers in this regard. Hence the defaulted Local Self Government Institutions are directed to submit the accounts of expenditure at once to avoid further withholding of instalments.
- 6. In the circumstances, Government are pleased to release 1/10<sup>th</sup> of the current years budget provision allocated to Local Self Government Institutions amounting to Rs. 166,71,79,900 (Rupees One hundred and Sixty Six crore Seventy One Lakh and Seventy Nine thousand and Nine hundred only) as 8th instalment of Expansion and Development fund for the month of January 2009 as per the entitlement envisaged in Appendix IV to the detailed Budget Estimates 2008-09 on condition that the instruction issued in the Government Order read as 5th paper above is carried out at once.
- 7. The Director of Panchayats will allot the net amount (excluding the deducted amount from 2008-09 allocation) set apart for each Grama Panchayat to the Secretaries of Grama Panchayats directly as stipulated in the Government Order read as first paper above subject to the conditions stipulated in the Government Order read as 5th paper above.

- 8. The Commissioner for Rural Development will allot the net amount jexcluding the deducted amount from 2008-09 allocation) set apart for each Block Panchayat to the Secretaries of Block Panchayats directly adhering to the conditions stipulated in the Government Order read as 5th paper above.
- 9. The Director of Urban Affairs will allot the net amount (excluding the deducted amount from 2008-09 allocation) set apart for each Municipality to the Secretaries of the Municipalities directly subject to the conditions laid down in Government Order read as 5th paper above.
- 10. Government are also pleased to allot the following amounts as the 9th instalment of the Development fund to the 14 District Panchayats and 5 Corporations as shown below.
