ORDER

As per the Government Order read as 1st paper above the Schedule of Rates (SoR) of electrical and civil items were revised w.e.f 1.4.2008. As per the Government Order read as 2nd above the rates of labour were also revised by allowing 20% increase w.e.f the date of the order.

- 2. The Chief Engineer, Administration as per his letter read as 3rd paper above has furnished proposals for revising the SoR taking into account the current market rates of cement, steel and bitumen. Government have examined the matter in detail and are pleased to issue orders revising the SoR as appended.
- 3. The revision of schedule of rates will be effective w.e.f 1.4.2009 and will be known as SoR 2009. The rates are inclusive of all taxes and VAT @ 4%.
