ORDER

- 1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per Government Order read as 3rd, 4th, 5th, 6th and 7th paper above sanction was accorded for the release of 1st, 2nd, 3rd, 4th and 5th installment of funds for Maintenance Expenditure for the month of April, May, June, July and August, 2009.
- 3. Now as per the Government Order read as 8th paper above, an amount of Rs. 42,80,44,000/- (Rupees Forty Two crore Eighty lakhs and Forty Four thousand only) was transfer credited from the Consolidated Fund under Major Head of Account, '3054 -Roads and Bridges' and '3604 - Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 - Deposits of Local Funds' as 6th installment for September, 2009 and also sanctioned for its release. Accordingly sanction is accorded for the release of Rs.25,39,89,400/- (Rupees Twenty Five crore Thirty Nine lakh Eighty Nine thousand and Four hundred only) for Maintenance Expenditure of Non-Road Assets and Rs.17,40,54,600/- (Rupees Seventeen crore Forty lakh Fifty Four thousand and six hundred only) for maintenance expenditure of Road Assets from the funds so transfer credited being 1/10th of allocation earmarked to the Local Self Government Institutions as 6th installment for the month of September, 2009.
- 4. The distribution of funds among the Local Self Government Institutions is based on the statement appended to the Government Order read as 8th paper above. The amount so transfer credited is exempted from treasury restrictions.
- 5. The Director of Panchayats will release the 6th installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Grama Panchayats. The Director of Urban Affairs will release the 6th installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Municipalities. The Commissioner for Rural Development will release the 6th installment of the 1/10th of the Maintenance Expenditure (Non Road Assets) to the Block Panchayats in accordance with the guidelines prescribed in para 3 of the Government Order read as 1st paper above.
- 6. As per the Government Order read as 9th paper above Government have decided to deduct an amount of Rs.343.148 lakh from the 6th installment of funds for Maintenance Expenditure (Road Assets) onwards from the District Panchayats concerned for the maintenance of roads under PMGSY scheme. Commissioner for Rural Development will draw the deducted amount and remit it to KSRRDA as ordered in Government Order 9th cited. Accordingly, Government are also pleased to release the following amounts as the 6th installment of maintenance fund to the District Panchayats and the corporations as follows:
