ORDER

As per the GOs read as first and second papers above, 12 Assistant Executive Engineers of the Local Self Government Engineering Cadre had been provisionally promoted as Executive Engineers under Rule 31 (a)(i) of KS & SSRs. In the DPC(H) Meeting held on 01.06.2010, it has been decided that the following 6 Engineers were not eligible for promotion to the post of Executive Engineers. Hence their names have not been included in the Select List.

In the WP(C).29383/2008 filed by Sri. K.T. Rajan, Executive Engineer, Thrissur Corporation and others with the prayer to the respondents not to revert the petitioners from the post of Executive Engineer retaining those who are not included in Ext P6 & P7 in the said post, the Hon'ble High Court in the order read as 4th paper above ordered that the petitioners shall not be reverted until further Orders. But, the Hon'ble High Court further ordered that this will not however stand in the way of the official respondents from promoting Assistant Executive Engineers who are senior to the petitioner to the post of Executive Engineer. It was also ordered that reversion of the petitioner can be effected only if after all the sanctioned posts are filled up in accordance with the Special Rules, the department finds that the petitioners are not by virtue of their seniority entitled to continue in office as Executive Engineers.

The DPC(H) held on 01.06.2010 decided that the following Executive Engineers, who were already promoted provisionally as Executive Engineers, are not eligible for regular promotion. Hence, the following Engineers are reverted with immediate effect from the post of Executive Engineer to Assistant Executive Engineer:

- 1. Sri. K.A. Suli
- 2. Sri. K.T. Rajan
- 3. Sri. E.K. Sanilan
- 4. Sri. P.G. Rajeev
- 5. Sri. N.R. Soman
- 6. Sri. R.S. Chandran

On reversion, the above Assistant Executive Engineers are posted as such as follows:
