Local Self Government Department - Establishment - Creation of Joint Programme Co-ordinator posts in MGNREGA in the cadre of Joint Development Commissioner in Alappuzha and Kollam Districts and Promotion and Posting in the cadre of Joint Development Commissioner, Deputy Development Commissioner and Assistant Development Commissioner - Sanctioned - Orders Issued.

ORDER

As per Government Order read as 1st paper above. Government have issued orders to strengthen NREGA implementation at district level by setting up a dedicated implementation mechanism and to this end created the post of Joint Programme co-ordinations and Assistant Programme Co-ordinators etc. For the purpose of creation of the posts it was proposed that the districts may be categorized as follows.

- Category A More than 50,000 households provided employment in a financial year and administrative cost within 6% limit. Category B Less than 50,000 households demanding employment in a year.
- 2. It has also been specified that the new posts are purely of temporary nature requiring continuous sanction from 1st of March of every year based on the actual (a) number of households that were provided with employment under NREGA (b) average person days created per nousehold during the year (c) Labour budget estimate for succeeding year and (d) administrative fund actually available for meeting staff cost. Based on these guidelines, Sanction was accorded to appoint 8 Joint Programme Co-ordinators in the districts of Palakkad, Thiruvananthapuram, Wayanad, Idukki, Thrissur, Malappuram, Kozhikkode and Ernakulam as per the G.O read as 2nd paper above and Joint Programme Co-ordinators posted as per the Government Orders read as 3nd and 4nd paper above.
- 3. The Commissioner for Rural Development in his proposal read as 5th paper above has now reported that as per the report of the state MGNREGS cell, the Alappuzha and Kollam districts have also qualified on the basis of the above criteria and requested for creation of Joint Programme Co-ordinators posts in the cadre of Joint Development Commissioner. The Commissioner for Rural Development has also recommended and forwarded a proposal for the creation of Joint Programme Co-ordinators posts in the cadre of Joint Development Commissioner in the districts of Alappuzha and Kollam. He has also submitted a proposal for posting of the consequent resultant vacancies of Deputy Development Commissioner and Assistant Development Commissioners.
- 4. In the above circumstances, Government are pleased to create the posts of Joint Programme Co-ordinations in the cadre of Joint Development Commissioner in the scale of pay Rs.20700-26600 in the districts of Alappuzha and Kollam to strengthen the institutional support mechanism of MGNREGA.
- 5. The following senior most Deputy Development Commissioners in the Rural Development Department are promoted and posted in the cadre of Joint Development Commissioners in the scale of pay of 20700 26600 on temporary basis subject to the final decision in the Writ petitions pending before the Hon'ble High Court in the matter.

- Sri.Sasidharan Nair K, Principal Extension Training Centre, Mannuthy, the senior most Deputy Development Commissioner in the Select List is promoted as Joint Development Commissioner and posted as Joint Programme Co-ordinators, MGNREGA, Kollam.
- Sri.V.Santhappan Nair, next senior most Deputy Development Commissioner now on deputation to KSUDP is promoted as Joint Development Commissioner and is allowed to continue on deputation in KSUDP.
- Sri.Sivakumar K, now on deputation to Suchitwa Mission as Programme Officer is promoted to the cadre of Joint
 Development Commissioner and is posted as Joint Development Commissionerate of Rural Development
- 4. Sri.K.Yusuf, Principal Extension Training Centre, Thalipparambu is promoted as Joint Development Commissioner and posted as Joint Programme Co-ordinators, MGNREGA, Kozhikkode.
- Sri.K.Shoukathali , Joint Programme Co-ordinator, NREGS Kozhikkode is transferred and posted as Joint Programme Co-ordinator , NREGA, Alappuzha.

The following sonior most Assistant Development Commissioners in the Rural Development Department are promoted and posted in the cadre of Deputy Development Commissioners in the scale of pay of 16650 - 23200 on temporary basis subject to the final decision in the Writ petitions pending before the Hon'ble High Court in the matter.

- 1.Sri.Bhuvanendran ', Assistant Development Commissioner (PA) Thiruvananthapuram, the senior most Assistant Development Commissioner in the select list is promoted as Deputy Development Commissioner and posted as Principal Extension Training Centre, Mannuthy.
- 2. Sri.Suresh Chandran N, Assistant Project Officer (P&M) Poverty Alleviation Unit, Kollam is promoted as Deputy Development Commissioner and posted as Principal Extension Training Centre, Thalipparambu.
