ORDER

1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.

2. As per the Government Order read as 3rd, 4th, 5th, 6th, 8th and 9th papers above sanction was accorded for the release of 1st, 2nd, 3rd, 4th, 5th and 6th installments of funds for Maintenance expenditure for the month of April, May, June, July, August and September 2010.

3. As per the Government Order read as 10th paper above, an amount of **Rs. 40,51,74,500/- (Rupees Forty crore Fifty One lakh Seventy Four thousand and Five hundred only)** was transfer credited from the Consolidated Fund under Major Head of Account, '3054 -Roads and Bridges' and '3604 - Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 - Deposits of Local Funds' as 7th installment for October 2010 and also sanctioned its release. Accordingly sanction is accorded for the release of **Rs.22,74,82,400/- (Rupees Twenty Two crore Seventy Four lakh Eighty Two thousand and Four hundred only)** for Maintenance Expenditure of Non-Road Assets and **Rs.17,76,92,100/- (Rupees Seventeen crore Seventy Six lakhs Ninety Two thousand and One hundred only)** for maintenance expenditure of Road Assets from the funds so transfer credited being $\frac{1}{10}$ th of allocation earmarked to the Local Self Government Institutions as 7th installment for the month of October, 2010.

4. In the Government Order read as 8th paper above, 6th and 7th installment of funds for Maintenance Expenditure to Municipal Corporations had already been released in advance.

5. The distribution of funds among the Local Self Government Institutions is based on the statement appended to the Government Order read as 10th paper above. The amount so transfer credited is exempted from treasury restrictions.

6. The Controlling Officers will release the 7th installment of the $\frac{1}{10}$ th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Local Self Government Institutions concerned in accordance with the guidelines prescribed in para 3 of the Government Order read as 1st paper above subject to the conditions stipulated in the circular cited.

7. Accordingly Government pleased to release the 7th installment of Maintenance expenditure to District Panchayats and Corporations as follows;


