### ORDER

1. In the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.

2. As per the Government Order read as 5th, 6th, 7th, 8th, 9th and 10th papers above sanction was accorded for the release of 1<sup>st</sup>, 2nd, 3rd, 4th, 5th and 6th installment of funds for Expansion and Development for the month of May, June, July, August, September and October 2010.

3. As per the Government Order read as 11<sup>th</sup> paper above sanction was accorded for the transfer credit of **Rs. 200,63,62,650/- (Rupees Two hundred crore Sixty Three lakh Sixty Two thousand Six hundred and Fifty only)** from the Consolidated Fund under Major Head of Account, '3604 - Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 - Deposits of Local Funds' to release the installment due for the month of November, 2010 (7<sup>th</sup> installment) being the Funds for Expansion and Development to Local Self Government Institutions. Sanction was also accorded for the release of **Rs. 200,63,62,650/- (Rupees Two hundred crore Sixty Three lakh Sixty Two thousand Six hundred and Fifty only)** being 1/10th of the net allocation earmarked to the Local Self Government Institutions in respect of Funds for Expansion and Development under different sectors as per the distribution in Appendix - IV to the Detailed Budget Estimates, 2010 - 11.

4. In the circumstances, Government are pleased to release 1/10th of the current years budget provision allocated to Local Self Government Institutions amounting to **Rs. 200,63,62,650/- (Rupees Two hundred crore Sixty Three lakh Sixty Two thousand Six hundred and Fifty only)** as 7<sup>th</sup> installment of Expansion and Development Fund for the month of November 2010 as per the entitlement envisaged in Appendix IV to the detailed Budget Estimates 2010-11.

5. The Controlling Officers will allot the net amount (excluding the deducted amount from 2010-11) set apart for Local Self Government Institutions concerned to their Secretaries directly as per the Government Order read as first paper above.

6. Government are also pleased to allot the following amount as the 7<sup>th</sup> installment of Development fund to the 14 District Panchayats and 5 Corporations as shown below.
