**ORDER**

Rule 20(2)(a) of the Kerala Municipality Building Rules 1999 states that "every owner shall permit the Secretary or any person authorised by the Secretary or by the Government for this purpose to enter the plot or building or premises at any time between 7 a.m. and 6 p.m. normally or at any other time as may be deemed necessary for the purpose of enforcing the rules"

2. Rule 157 of the Kerala Municipality Building Rules provides for the formation of a Vigilance Squad in every District to detect, prevent and report on the illegal construction. Sub rule (5) to rule 157 states that "Government may also authorise any officer (s) to perform the functions entrusted to the Squad. Such officer(s) may also inspect site, verify records and or conduct such enquiries as required and furnish report to the Government. Such officer(s) may, at the time of inspection, inform the Secretary, in writing, the illegal constructions noted".

3. Now, Government hereby authorise the Senior Town Planner (Vigilance) Local Self Government Department, Government Secretariat, Thiruvananthapuram to perform the duties as provided under rules 20(2)(a) and 157(5) of the Kerala Municipality Building Rules 1999.
