ORDER

Government as per the G.O. read as 1st paper above have decided to liquidate the SERIFED (Kerala State Sericulture Co-operative Federation Limited) and to transfer its assets and to absorb its staff into the Department of Panchayat, the Commissionerate of Rural Development and the Kerala Khadi and Village Industries Board with specific terms and conditions which included the concurrence of the Kerala Public Service Commission also.

As per the G.O read as 2nd paper above sanction was accorded for the creation of 283 posts under the Commissionerate of Rural Development and under the Department of Panchayats as permanent / Supernumerary basis in addition to the cadre w.e.f. 1.07.2010 for the absorption of the staff of SERIFED in Government Departments.

In pursuance to the above orders, Government have requested for the concurrence of the Kerala Public Service Commission for the creation of posts and absorption of the SERIFED staff in Government Departments. But the Kerala Public Service Commission as per its letters read as 3rd paper above has disagreed to give concurrence to the Government decision taken vide G.O. read as 2nd paper above.


