ORDER

- As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per the Government Order read as 3rd, 4th, 5th, 6th, 8th, 9th, 10th, 12th and 13th papers above sanction was accorded for the release of 1st, 2nd, 3rd, 4th, 5th, 6th, 7th, 8th and 9th installments of funds for Maintenance expenditure for the month of April, May, June, July, August, September, October, November and December 2010.
- 3. As per the Government Order read as 14th paper above, an amount of ₹ 44,05,79,500/- (Rupees Forty Four crore Five lakh Seventy Nine thousand and Five hundred only) was transfer credited from the Consolidated Fund under Major Head of Account, '3054 -Roads and Bridges' and '3604 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 Deposits of Local Funds' as 10th and last installment for January 2011 and also sanctioned its release. Accordingly sanction is accorded for the release of ₹ 24,76,35,100/- (Rupees Twenty Four crore Seventy Six lakh Thirty Five thousand and One hundred only) for Maintenance Expenditure of Non-Road Assets and ₹ 19,29,44,400/- (Rupees Nineteen crore Twenty Nine lakhs Forty Four thousand and Four hundred only) for maintenance expenditure of Road Assets from the funds so transfer credited being 1/10th of allocation earmarked to the Local Self Government Institutions as 10th and last installment for the month of January 2011.
- 4. In the Government Order read as 8th paper above, 6th and 7th installment of funds for Maintenance Expenditure to Municipal Corporations had already been released in advance.
- 5. The distribution of funds among the Local Self Government Institutions is based on the statement appended to the Government Order read as 14th paper above. The amount so transfer credited is exempted from treasury restrictions.
- 6. The Controlling Officers will release the 10th installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Local Self Government Institutions concerned in accordance with the guidelines prescribed in para 3 of the Government Order read as 1st paper above subject to the conditions stipulated in the circular cited.

- 7. As per the existing guidelines the expenditure for the maintenance of roads constructed and transferred to District Panchayats under PMGSY for 5 years shall be met from the Maintenance Fund (Road Assets) of District Panchayats concerned. Accordingly, the Member Secretary, KSRRDA vide his letter read as 11th paper above requested the Government to deduct total amount of ₹ 361.215 lakh from the fund earmarked for maintenance of road assets of District Panchayat for the year 2010-11. Considering this proposal Government have decided to deduct the available amount (10th installment) under Funds for Maintenance Expenditure (Road Assets) allotted to District Panchayats for the maintenance of roads constructed under PMGSY. The Commissioner for Rural Development is authorized to draw and remit the deducted amount from the Road asset Fund of District Panchayat to the Member Secretary, KSRRDA.
- Accordingly Government pleased to release the 10th and last installment of Funds for Maintenance expenditure to District Panchayats and Corporations as follows;

- 9. The Controlling Officers shall confirm that Water Charge arrears is deducted as per the instructions contained in the Government Order cited 7th, and 14th papers above. Deduction of water charge arrear from the allotment of Kozhikode Corporation is withheld until further orders in this regard as decided in the meeting held on 02.09.2010 considering the dispute between Kerala Water Authority and Corporation. The Controlling Officer shall furnish a consolidated statement pertaining to deduction of water charges from General Purpose Fund & Maintenance Fund (Non-Road) and remittance of the same with progressive total to the Finance (Budget Wing J) Department as ordered in Government Order read as 14th paper above with copy to Local Self Government Department.
- 10. The Director of Urban Affairs will draw the amount deducted from the allotment of Corporations being water charge arrear and remit it to Kerala Water Authority forthwith under intimation to Government.
