As per the Government Order read as first paper above Government have issued guide lines for giving assistance to the beneficiaries under IHSDP

As per the note read as second paper above the Executive Director, Kudumbashree has reported that the cost of houses under IHSDP has been increased to Rs.1,00,000/- and in the latest round project up to Rs.1,30,000/- and submitted the following schedule to be adopted for the release of installments of funds to be paid for new houses under IHSDP:

Rs.1,30,000/-	Rs.30000/- on signing of agreement by the beneficiary	Rs.45000/- on completion of foundation level, based on recommendation by ADS and CDS	Rs.45000/- on completion of lintel level, based on certificate issued by ADS/CDS and Engineering wing of the ULB	Rs.10000/- on completion of the house, based on certificate issued by ADS/CDS and Engineering wing of the ULB


