**ORDER**

As per Government Order read as first paper above Government have approved the scheme for the creation of "Urban Poverty Alleviation Fund (UPA Fund)" as required under section 284 of the Kerala Municipal Act, 1994. Utilization of the Urban Poverty Alleviation Fund was linked to the SJSRY scheme vide Government Order read as second paper above. Government have clarified the matter further, as per Government order read as 3rd and 4th papers above. As per the revised guidelines of SJSRY issued in the Government order read as fifth paper above, the Loan-cum-Subsidy schemes under USEP and UWSP components of SJSRY are being implemented directly by the Municipalities.

Now the Executive Director, Kudumbashree has requested to issue necessary orders to facilitate the utilization of 2% UPA fund by the Municipalities, in view of the revised SJSRY guidelines.

Government have examined the matter in detail and are pleased to accord permission to utilize the funds available under 2% UPA Allocation transferred to the account of the UPA Cell as per the guidelines for USEP and UWSP Loan-cum-Subsidy scheme components of SJSRY and to add the unspent balance available under UPA Fund to the annual allocation made by the Kudumbashree Mission to the Municipalities under USEP and UWSP components and plans for utilization to be made as per the SJSRY guidelines.
