ORDER

In the Government Order read as 1st paper above Government have issued revised guidelines for the allocation of funds to Local Self Government Institutions.

2. As per the Government Order read as 5th, 6th, 7th, 8th, 9th, 10th, 12th, 12th and 13th papers above sanction was accorded for the release of 1st, 2nd,3rd, 4th,5th, 6th, 3th, 8th, 9th instalment of funds for Expansion and Development for the month May, June, July, August, September, October, November & December 2010 and January 2011.

3. As per the Government Order read as 14th paper above sanction WES accorded for the transfer credit of ₹202,53,62,650/-(Rupees two hundred and two crore fifty three lakh Sixty two thousand six hundred and fifty only) from the consolidated fund uncer Major head of account 3604-compensation and assignments to Local bodies and Panchayat Raj Institutions to the Public Account under Major Head of Account '8448-Deposits of Local funds' to release the instalment for the month of February 2011(10th and final instalment) being the funds for Expansion and Development to Local self Governments Institutions and Special Incentive to award winning Local self Governments Institutions for 2008-09 .Sanction was also accorded for the release of ₹ 202,53,62,650/-(Rupees two hundred and two crore fifty three lash Sixty two thousand six hundred and fifty only) being 1/10th of the net allocation earmarked to the the Local Self Government Institutions in respect of Funds for Expansion and development under different sectors as per the distribution in Appendix -IV to the detailed budget estimates, 2010-11 and release of Special Incentive for 2008-09 as ordered in G.O(Rt)519/2010/LSGD dated 17.02.2010.

4. In the circumstances, Government are pleased to release 1/10th of the current years budget provision allocated to Local Self Government institutions amounting to ₹202,53,62,650/-(Rupees two hundred and two crore fifty three lakh Sixty two thousand six hundred and fifty only) as 10th instalment of Expansion and Development fund for the month of February 2011 as per the entitlement envisaged in Appendix IV to the detailed budget

estimates 2010-11.

5. The Controlling Officers will release the net amount (excluding the deducted amount from 2010-11) set apart for Local Self Government Institutions concerned to their Secretaries directly as per the Government Order read as first paper above.

6. The amount that ordered to be deducted towards water charge arrears from Non road maintenance fund and General Purpose Fund but remained outstanding even after deduction from 10th and 12th (last) instalment of Fund for maintenance expenditure & General Purpose Fund respectively should be deducted from the instalment of Plan fund as ordered in the Government Order read as 13th paper above. The amount so deducted will be adjusted while releasing the General Purpose Fund to Local Self Government Institutions during April 2011.

7. The Controlling Officers shall see that requisite amount is deducted from the General Sector of Funds for Expansion and development for repayment of principal amount of loan availed by Local Self Government Institutions for EMS Housing Scheme as ordered in G.O(Rt) 3568/10/LSGD dated 15.11.10. The available fund is deducted from the allocation of District Panchayat as follows.

8. Accordingly Government are pleased to allot the following amount as the 10th & final instalment of Development fund to the 14 District Panchayats and 5 corporations as shown below.
