ORDER

1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.

2. As per the Government Order read as 4th and 5th papers above sanction was accorded for the release of 1st, 2nd, and 3rd installments of Funds for Traditional Functions for the month of April, May

and June 2011. 3. As per Government Order read as 6th paper above sanction was accorded for the drawal of total amount of Rs.49,33,99,999/- (Rupees Forty Nine Crore Thirty Three lakh Ninety Nine thousand Nine hundred and Ninety Nine only) from the budget provision under head of account 3604-00-200-93 (N.P.) being the 4th installment of Funds for Traditional Functions for the month of July 2011. Out of this, an amount of Rs.2,64,76,331/- (Rupees Two Crore Sixty Four lakh Seventy Six thousand Three hundred and Thirty One only) is transfer credited to the major head of account 2515-other Rural Development Programme to recoup the salary cost (for July 2011) in respect of Engineering Cadre under Local Self Government Institutions as ordered in the Government Order read as 3rd paper above and Rs. 46,69,23,668/- (Rupees Forty Six Crore Sixty Nine lakh Twenty Three thousand Six hundred and Sixty Eight only) was transfer credited to the Deposit Account of Local Self Government Institutions under State's Public Account being 4th installment of Funds for Traditional Functions for the month of July 2011.

4. Accordingly, sanction is accorded for the release of Rs. 46,69,23,668/- (Rupees Forty Six Crore Sixty Nine lakh Twenty Three thousand Six hundred and Sixty Eight only) being the 4th installment of Funds for Traditional Functions for the month of July 2011 after adjusting the salary

cost of Engineering cadre under Local Self Government Institutions.

5. The distribution of funds among the Local Self Government Institutions effected are as shown in the statement appended to Government Order read as 6th paper above. The amount so

transfer credited is exempted from treasury restrictions.

6. The Controlling Officers will release the 4th installment to the Local Self Government Institutions concerned, being 1/12th of the funds earmarked for Traditional Functions (after adjusting the salary cost of Engineering Wing), in accordance with the guidelines prescribed in Para 3 of the Government Order read as 1st paper above subject to the conditions laid down in the circular cited.

7. Director of Urban Affairs is authorised to draw the amount (including the amount deducted vide G.O.5th cited) deducted towards water charge arrear and to remit it to Kerala Water Authority under intimation to Government.

8. Accordingly Government are pleased to release the 4th installment of General Purpose Fund to District Panchayats and Corporations as follows.
