As per G.O(MS)No.2/11/LSGD dated 1/01/2011 Government have accorded sanction for the implementation of the Kerala Local Government And Service Delivery Project(KLGSDP). The Project focuses on improving the institutional and service delivery capacities of Grama Panchayats and Municipalities in the State. The long term vision is that the systems introduced through the Project will become an integral part of the Institutional frame work of the Local Self Government in Kerala . The Project has four components with an estimated cost of \$260 million of which the World Bank credit from the IDA window would be \$ 200 million and \$ 60 million is the Government counterpart

In order to take decisions on various issues concerning project implementations, Government are pleased to constitute a Coordination Committee comprising the following:-

The powers and functions of the Co-ordination Committee would be as follows

1. Regular review work of the consultants Until Project Completion.
2. Regular monitoring of Project activities and decision making to facilitate removal of bottlenecks that may arise during the course of Project implementation.
3. Sanction of temporary posts and contractual appointments in the Project Management Unit for the Project period.
4. Approval of vehicle procurement for Project implementation.
5. Approval of hiring of office spaces as necessary, for Project Management Unit, and Consultants.
6. Regular review of Project Progress - monthly and annually - And achievement regarding overall physical and financial targets.

The Project Director of KLGSDP who will be the Convener of the Coordination Committee and will discharge the following functions:

1. Convene regular meetings of the Coordination Committee in consultation with the Chairman.
2. Prepare the minutes of the meeting and circulate it to the members after approval of the Chairman.
3. Ensure compliance of all decisions of the Coordination Committee.

Other general points regarding the function of the Coordination Committee are as under:

1. Further examination of the decisions of the Coordination Committee and scrutiny and approval at various levels by the line departments concerned shall not be necessary and as such the same shall be complied with by the concerned Departments, Project Management Unit and Execution support agencies of Kerala Local Government And Service Delivery Project (KLGSDP).
2. The Administrative Department for the above Committee will be the Local Self Government Department.
3. The tenure of the Coordination Committee shall extend till Project completion.
4. The Committee shall meet at least once in a fortnight/month or more frequently if necessary.
5. The quorum of the Coordination Committee would be at least three regular members and special invitees relating to the subject in the agenda.


